



# Prevent Risk Assessment – September 2025

Moirra Primary School recognises that it has a duty under Section 26 of the Counter-Terrorism and Security Act, 2015, in the exercise of its functions, to have due regard to the need to prevent people from being drawn into terrorism.

**This self-evaluation document has been written with reference to advice from the DfE and our own school policies. It is not a statutory document and use of the tool is not mandatory but it contains both requirements and recommended good practice activities to meet those requirements.
